Merchandise Booth:

- A copy of the Sales Tax must be attached to the application and displayed at the event. You are responsible for collecting and submitting sales tax to the State of Texas Comptroller. The event organizers are NOT responsible for collecting and submitting your sales tax!
- There are NO restrictions for same-type items sold.

Food/Beverage Booth:

- All food must be prepared in a state-approved facility and served according to state regulations.
- A copy of the food handler license must be attached to the application.
- Copy of items you will have for sale at the event. The TNT Fest Committee can ask you not to sell items not listed on the application. Changes can be made 24 hours before the event.

Information/Activity Booth:

- Non-profit organizations must provide proof to consider waiving the booth fee.

Rules:

- The Jacksboro TNT Fest Committee shall be the final authority to interpret the rules and regulations and select vendors.
- The EVENT PLANNERS AND PARTICIPANTS are not responsible for accidents, lost, stolen, damaged property, or hurt feelings.
- The sale of any item(s) that may prove harmful is strictly PROHIBITED.

- You are responsible for the cleanliness of your area. Any space left in disarray or with loose trash or garbage will disqualify you from future participation.
- You are responsible for all booth setup and teardown. The Jacksboro TNT Fest Committee does not have the staff to assist and will not supply tables, chairs, tents, etc. Electricity will be available upon request and for an additional fee. It is limited availability.
- Booth location will be made on a first-come, first-served basis.
- **No** four-wheelers, golf carts, bicycles, motorized scooters, UTVs, etc., will be allowed. Only medically necessary motorized assistance will be allowed.
- **There are NO** vehicles in the booth area during sales. From 11:00 am till the completion of fireworks.
- **NO** firearms will be allowed at the event. Visitors will be asked to leave the area and will not be allowed to participate.
- **There is NO** gambling at the event.
- **NO PYROTECHNICS, FIREWORKS, or SPARKLERS ALLOWED**
- **NO REFUNDS - RAIN OR SHINE - NO EXCEPTIONS, REGARDLESS OF CIRCUMSTANCE.**

Booth Property & Liability:

- The booth exhibits at his/her own risk. The event will be monitored by the Law Enforcement agencies of the Jacksboro Police Department/Jack County Sheriff's Department. Still, all booth(s) understand and expressly agree that in consideration of the acceptance of this registration entry, I, the undersigned, assume full responsibility for any injury or accident that may occur during participation in this event or while I am on the premises of this event: and I with this release and hold harmless the Jacksboro TNT Fest, the City of Jacksboro and all of their entities, organizations, directors, sponsors or promoters associated with this event or their agents or employees, or otherwise (aka EVENT PLANNERS & PARTICIPANTS).
- The Jacksboro TNT Fest Committee shall be the final authority that interprets the rules and regulations and selects booths.
