

ORDINANCE O-18-2025

AN ORDINANCE OF THE CITY OF JACKSBORO, TEXAS AMENDING THE FEE APPENDIX OF THE CITY OF JACKSBORO CODE OF ORDINANCES AS RELATED TO APPENDIX A: FEE APPENDIX: AND, ARTICLE A4.000 BUSINESS RELATED FEES; SECTION A4.001 SALE OF ALCOHOLIC BEVERAGES; ARTICLE A6.000 AIRPORT FEES; AND ARTICLE A7.000 UTILITY FEES; SECTION A7.003 WATER RATES AND CHARGES, REPEALING ALL CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Jacksboro has adopted and established certain fees, for services as set forth in the Fee Appendix to the Code of Ordinances, adopted by separate ordinances relative to the specific topic and consolidated into the Fee Appendix to the Code of Ordinances; and

WHEREAS, the City of Jacksboro desires to provide a schedule of fines, rates, charges, fees and permits for services provided to the residential and commercial property owners within the corporate limits and the extraterritorial jurisdiction of the City; and

WHEREAS, the Fee Appendix documents the various schedules of fines, rates, charges, fees and permits as follows:

ARTICLE 2.000 ANIMAL CONTROL FEES
ARTICLE 3.000 BUILDING AND DEVELOPMENT RELATED FEES
ARTICLE 4.000 BUSINESS RELATED FEES
ARTICLE 5.000 PARK FEES
ARTICLE 6.000 AIRPORT FEES
ARTICLE 7.000 UTILITY FEES
ARTICLE 8.000 MISCELLANEOUS FEES

WHEREAS, the City Council deems it to be in the best interest of the City of Jacksboro to periodically review all pertinent fines, rates, charges, fees and permits to ensure that the assessment of such fines, rates, charges, fees and permits recovers the costs associated with providing such services, including operation and maintenance, to residential and commercial users within the corporate limits and extraterritorial jurisdiction of the City; and

WHEREAS, the City Council also deems it necessary to align all fees and charges with those laws enacted by the State of Texas, and periodically must review and/or repeal any fees and charges that are no longer lawful for the City to charge; and

WHEREAS, the City Council has conducted a review of its fines, rates, charges, fees and permits and has determined that it is in the best interest, health, safety and welfare of the citizens of the City of Jacksboro to revise the fees stated herein to recover the costs of service, operation and maintenance associated with these municipal services, and to repeal any fees that may longer be legally charged..

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JACKSBORO, TEXAS, THAT:

SECTION 1. All premises are hereby adopted as the legislative findings of the City Council, are true and correct and are incorporated herein by reference as if fully set forth herein.

SECTION 2. The Fee Appendix of the City of Jacksboro Code of Ordinances is hereby amended relative to Appendix A: Fee Appendix to establish a schedule of fees and permits associated with the municipal activities for the City of Jacksboro, Texas, as set forth in the attached Attachment A.

SECTION 3. The revised schedule of fees will apply to all services provided to residential and commercial users within the corporate limits and extraterritorial jurisdiction of the City.

SECTION 4. REPEAL OF CONFLICTING ORDINANCES. All provisions of the Code of Ordinances of the City of Jacksboro, Texas, in conflict with the provisions of this Ordinance, be, and the same are hereby, repealed, and all other provisions not in conflict with the provisions of this Ordinance shall remain in full force and effect.

SECTION 5. SEVERABILITY. Should any word, sentence, paragraph, subdivision, clause, phrase, or section of this Ordinance, or of the Code of Ordinances, as amended hereby, be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of said Ordinance or the Code of Ordinances, as amended hereby, which shall remain in full force and effect.

SECTION 6. EFFECTIVE DATE. This Ordinance shall take effect immediately upon its passage and approval.



APPENDIX A: FEE APPENDIX
ARTICLE A4.000 BUSINESS RELATED FEES
§A4.001 SALE OF ALCOHOLIC BEVERAGES

§ A4.001. Sale of alcoholic beverages.

As allowed by the Texas Alcoholic Beverage Code, permit fees shall be as follows:

(1) For on-premises consumption, the city hereby levies ~~an annual a biennial~~ fee in a sum equal to fifty percent of the state's third renewal fee for a mixed beverage permit, **unless the establishment falls under the category of food service establishment, retail food store, mobile food unit, roadside food vendor, or temporary food service establishment that has already paid a fee to operate to the department or to any county, municipality , or public health district,** except a temporary or agent's license issued for premises locations within the corporate limits of the city; and

(2) For off-premises consumption, the city hereby levies ~~an annual a biennial~~ fee in a sum equal to fifty percent of the state's fee for a retailer's off-premises license.

§ A7.003. Water rates and charges.

- (a) Monthly rates. The monthly water rates to be charged and collected by the city from all customers within the city limits and obtaining city services for water shall be hereby fixed as follows:
